4 It was my intent, it is my intent, it will be my intent to convert this lawsuit to a minimum  
5 of 1 Billion Dollar Class Action Lawsuit(TM). After finalizing the document (Exhibit  
6 0001) at about 20:31 (PMT, Pacific Military Time), we began the actual process of  
7 sending the document to recruit lawyers and law firms on Saturday, October 05, 2019.  
8 Please see the Exhibit 0001. However, in an effort to preserve my rights to file a lawsuit  
9 I am doing so by filing these now.  
10

11 I have copied and pasted the beginning of the actual text of that Special Open Letter  
12 (OL). It begins with the words "We at Citizens For A Better America(R)  
13 (CFABA.ORG) ... all the way to my signature line. I have also copied and pasted the  
14 section that has to do with the two government entities that I am bringing lawsuits  
15 against. The CA Department of Social Services and the Los Angeles County  
16 Department of Public Social Services (LACO DPSS).

18 I am also including Exhibit 0003 the actual judicial order by Judge Eli Palomares which  
19 (LACO DPSS) has treated as meaningless trash.

14 I, Robert Colaco, Founder of Citizens For A Better America(R) (CFABA.ORG), am  
15 looking for lawyers and law firms that can bring minimum of 1 (One) Billion Dollar Class  
16 Action Lawsuits(TM) against several government entities and large private enterprise  
17 companies. I am looking for those who can do so on a contingency-fee basis.

20 Background information:  
21 -----

22  
23 I believe that the founders of the United States of America created an absolutely  
24 phenomenal country. They did so by creating a structure in which we as citizens would  
25 have freedoms, plus opportunities for us to fix within our government those flaws that  
26 we believe need to be fixed. I believe that our founders truly blessed us with the  
27 foundation that we needed to have a great nation. They did so through foundational

1 documents such as the Declaration of Independence, the Constitution of the United  
2 States, and other great documents [101].  
3

4 I am opposed to bad government at any level of government and throughout every part  
5 of the United States of America. Our Honorary National Chairman Congressman Bill  
6 Dannemeyer (1929-2019) said to me once, "I know why you work so hard as a  
7 volunteer in politics; because you do not want to see America become like Iraq." He is  
8 correct.  
9

10 So, if you are a patriot (one who loves and defends his or her country) of these United  
11 States of America, I as a fellow patriot invite you to read this Open Letter. Or, if you are  
12 potentially intrigued or favorable to the concept of bringing about the filing of these  
13 minimum of 1 (One) Billion Dollar Class Action Lawsuits(TM) for no other reason but for  
14 the potential earnings for you and/or your law firm, then I would encourage you in the  
15 strongest terms to read this Open Letter. Thank you in advance for doing so.

18 Why do I want to bring these lawsuits against those who are now on the CFABA.ORG  
19 Infamous List(TM)?  
20 -----  
21

22 This for me is a matter of serious principle. I was born in Baghdad, Iraq, and legally  
23 immigrated to the United States in 1969 as a 12-year-old boy with family members. So, I  
24 could have been a "DACA" child. I became a naturalized U.S. citizen in 1976. I believe  
25 strongly that at the very minimum government agencies in the United States of America  
26 (USA) cannot and should not be allowed to deceive, make commitments they do not  
27 keep, or just flat-out lie to their constituencies (people they have sworn to serve).  
28

1 This, of course, includes but is not limited to government agencies from the lowest to  
2 the highest in the United States of America (USA). I believe this mistreatment has  
3 happened to me, and as a matter of serious principle I believe it should not happen to  
4 anyone else.

5  
6 The "serious principle" mentioned above is one of the reasons that I became seriously  
7 involved in politics in December 1988 by beginning my candidacy for the U.S. House of  
8 Representatives in a district that was within the City of Los Angeles, and beyond in  
9 California. During my campaign for the U.S. Congress from December 1988 to June  
10 1992, I personally met about 35,000 people.

11  
12 After my run for the U.S. Congress, I began a political organization called Citizens For A  
13 Better America(R) (CFABA.ORG) on October 15, 1992. Its primary purpose was limited  
14 to electing morality and values-based candidates from the lowest to the highest political  
15 positions all over the (USA).

16  
17 In short, my dealings with our legal system seemed to get more and more educational  
18 throughout my adult life. However, that education was not a positive one. Then on May  
19 12, 2010, I had to file a lawsuit against the trustee of my parents trust. This was one of  
20 those non-positive experiences with our legal system from the standpoint of the  
21 trustee's lawyer having the license to be able to do any unprincipled actions and get  
22 away with those actions. I came to discover that bar associations were basically  
23 overwhelmed and for all intents and purposes were unable to do anything to police or  
24 truly regulate lawyers. From that point forward I saw lawyers (including but not limited  
25 to an Assistant District Attorney) do what I stated earlier "cannot and should not be  
26 allowed to deceive, make commitments they do not keep, or just flat-out lie to their  
27 constituencies (people they have sworn to serve)."

1 The most offensive and unacceptable was when my wife Gail (who deeply cared and  
2 loved her mother) and I were attempting to take care of her mother and to keep her  
3 mother from injury or death had Kaiser Permanente and their provider Little Company  
4 Of Mary Hospital (please see point #5 below, concerning "large, private enterprise  
5 entities"), basically treating me as if I was a criminal for having the objective of keeping  
6 her mother from injury or death.

7  
8 Gail and I would discover that those kinds of institutions are able to do whatever they  
9 want to do, and government agencies basically believe that family members all are in  
10 fact guilty of abuse of especially family members who are seniors.

11  
12 We would also discover during our approximately two-year nightmare that these  
13 government entities basically believed that the protections that are guaranteed to all  
14 American Citizens in our American Foundational Documents [101] were meaningless  
15 trash. This also brought me to the place where I believed "The Prosecution Team" of  
16 the county of Los Angeles and the State of California were really not much better than  
17 the legal system of Saddam Hussein's Iraq, the very nation that my parents fled from  
18 [102]. It is my passion to do everything that I can do within legal means to see to it that  
19 no American citizens ever experiences what we experienced. There is so much more  
20 that I can say about these issues, but I am attempting to keep this Open Letter as short  
21 as possible.

22  
23 As stated in our website Our Legal System Is Broken! (OurLegalSystemIsBroken.com),  
24 "There is much more to the story but just for the record the criminal charges against  
25 Robert and Gail Colaco were left as (UTP), "Unable To Proceed," after about 14 months  
26 of court when Gail's mother, the complainant, whom two doctors diagnosed with  
27 Alzheimer's disease, was moved out of state by Gail's brother to keep Gail from getting  
28 conservatorship. So, bottom line Robert and Gail still DO NOT have a criminal record

1 even though "The Prosecution Team" worked very hard to get them a criminal record.  
2 That UTP occurred on Monday, September 30, 2013. There was another serious  
3 problem with the Los Angeles County court system on or about December 6, 2016 that I  
4 would very much like to bring a class action lawsuit of those issues.

5  
6 I am not certain how many lawyers reading this Open Letter would understand the  
7 injustice that I have experienced as a Pro Per without truly walking in my shoes. I  
8 understand that attorneys have chosen the law as their life's work. Yet, what I am  
9 requesting is for lawyers and law firms to be truly open minded about what I considered  
10 not receiving the "justice for all" that is in "The Pledge of Allegiance."

13 Why am I pursuing large, class action lawsuits?  
14 -----

15  
16 Our organization purchased an Internet domain name called (OpenLetters.info) on  
17 August 5, 2008, for the purpose of writing Open Letters to government agencies and  
18 also private enterprise entities with which we were having problems. (By visiting that  
19 website, you can see that we had been writing Open Letters practically since the  
20 founding of Citizens For A Better America(R).) We published those Open Letters on one  
21 of our websites. We also disseminated those Open Letters as we would disseminate  
22 other documents. While that website had an effect, we did not believe it was enough of  
23 an effect.

24  
25 I again truly discovered that our legal system is broken in May 2010, when I filed a  
26 lawsuit in which I was a Plaintiff in Pro Per. Since that time, I have believed I had no  
27 choice but to do everything that I can do, on both a personal level as well as an  
28 organizational level, to bring about changes and fixes in that broken legal system.

1 Obviously, I will pursue that objective only within legal means. In this, I draw inspiration  
2 from Nathan Hale's last words before being hanged: "I only regret that I have but one  
3 life to give for my country" [103].

4  
5 On behalf of our political organization, Citizens For A Better America(R) (CFABA.ORG),  
6 I purchased an additional Internet domain name called (OurLegalSystemIsBroken.com).  
7 We launched this domain with content in May 2018.

8

10 The Primary Goal:

13 The concept of these minimum of 1 (One) Billion Dollar Class Action Lawsuits(TM) is  
14 not about the money for me to get personally. My understanding is that a "Super  
15 Plaintiff" (potentially myself) could receive only \$20,000 for the work of bringing about  
16 these class action lawsuits. I have however found in my life that small businesses to  
17 very large government agencies are greatly motivated by money and certainly by the  
18 loss of that money, especially in the context of their budgets being affected.

19  
20 Rather, the goal is about fixing the wrongs that I passionately believe need to be fixed,  
21 so that the United States of America does not follow the negative course of Iraq, the  
22 country in which I was born and lived until the age of 12.

23

21 - Regarding the bringing of these massive class action lawsuits against the part of our  
22 government entities that are the most needed by the individuals that are the least able  
23 to fight for themselves when they have been abused and wronged as my wife Gail and I  
24 have been:

26 I am speaking of the Los Angeles County Department of Public Social Services (LACO  
27 DPSS) and the State of California regulatory body that is to regulate the activities of

2 government entities are very seriously broken.

3  
4 By all the evidence that is available to me, their ability to retaliate against individuals  
5 that have not worshiped at their altar is nothing but absolutely stunning, as we have  
6 personally experienced. In fact, so much so that we decided to actually publish online  
7 for the entire world to see all of the emails that we have sent to both since December  
8 14, 2012.[106]

9  
10 In fact, in the last communication that I had with the assistant to the Judge [107] that  
11 ruled in our favor after a very long telephonic judicial hearing and a request by that  
12 Judge to have additional time to prepare his ruling, the Los Angeles County Department  
13 of Public Social Services (LACO DPSS) basically treated his judicial ruling as  
14 meaningless trash. I do not know what the statute of limitations are with all the other  
15 class action lawsuits that I would like to bring these class action lawsuits are probably  
16 the most closest to my heart because of all the implications but not limited to the fact  
17 that I have spent the most amount of time, energy, and distress in dealing with these  
18 entities and definitely last but not least all of the documents that I have written which  
19 can be seen at [106].

20  
21 This lawsuit under the section "Appeal Rights" states the following:

22  
23 "You may ask for judicial review of this decision by filing a petition in Superior Court  
24 under Code of Civil Procedure 1094.5 within one year after you receive this decision.  
25 You may file this petition without asking for a rehearing. No filing fees are required.  
26 You may be entitled to reasonable attorney's fees and costs if the Court renders a final  
27 decision in your favor. You may contact Legal Services for assistance."
