01. INTRODUCTION:

01.01. It is my strongest hope, desire, and goal to not sound or be rude, unkind, or to show any disrespect as I make my following remarks.

01.02. It is also my strongest hope, desire, and goal to communicate with you as truthfully and clearly as I possibly can so that you would understand what I am trying to say to you and thereby no misunderstandings between us develops any more than it already has.

01.03. To that end if you believe there is a misunderstanding or something does not make sense to you, please do not hesitate to contact me.

01.04. It is however my complete and total expectation that you would have read my entire set of documents, not just skimmed it, or done something like just looking at the first and last paragraph of each document.

01.05.01. I am not a lawyer. I am making statements within this legal filing that will need to be dealt with, by disinterested legal bodies.

01.05.02. The problems that have taken place with the Los Angeles County Department of Public Social Services(LACO DPSS) have gone on since within days (August 17, 2012) of us walking into their Lancaster, California office. The first time that I wrote an e-mail was on 20121214_1307 also known as (AKA) December 12, 2012 at 1:07 PM.

2 01.05.03. Please find for you, Judge Brian C. Yep Exhibit-0010 and for Anita
3 Susan Brenner, the lawyer representing the Los Angeles County(LACO) a public
4 entity and the Los Angeles County Board of Supervisors (LACO BOS). As both
5 of you can see that it is a printing of a document which has in the top right hand
6 section of the document CASE #19AVCP00260. At the center bottom of the
7 document is the Exhibit-0010. If you look at the date and time of the document in
8 the upper portion of the document you will see that the time is Eastern Time since
9 the server that we use is in the Eastern Time Zone.

11 01.05.04. For Anita Susan Brenner, all of these uploaded files will be in the folder
12 that is dedicated for this case #19AVCP00260. That folder is
13 (<http://openletters.info/ol-pdfs/0003/>). All the file names will begin with
14 (20200811_FD the FD stands for Filed Date, the date that it was filed with the
15 Lancaster, California court. Obviously the EXH stands for Exhibit and the
16 20121214_1307 stands for the date and time of the original document at the
17 following website link: (<http://ourlegalsystemisbroken.com/ca-gov-ol/>) which I had
18 submitted to the court in my initial filing.

20 01.05.05. For other documents Exhibits I will do the same thing as I described in
21 (01.05.03. and 01.05.03.) as long as it does not interfere with the text on the
22 document.

24 01.06. Judge Brian C. Yep, while I would like very much to print each and every
25 document of the estimated about 200 documents that I have written and that are
26 posted on our website (<http://ourlegalsystemisbroken.com/ca-gov-ol/0003>), (my
27 Exhibit 0002, which was filed with the initial lawsuit/petition) I have several

1 challenges to be able to do just that. So as an example the first document will be

6 01.06.01. First and foremost I do not have any kind of confidence that in me doing
7 just that they you Judge Brian C. Yep, would not find that action to be to use the
8 word that you stated when I was in your courtroom on February 6, 2020 which was
9 "inappropriate".

11 01.06.02. My financial resources. What I mean by that is my rather high concern
12 that I will run out of toner in my printer and I do not have additional toner to place
13 in the printer when that happens.

15 01.06.03. My physical body resources. What I mean by that is what we have
16 stated on our website (<http://openletters.info/dpsslaca/index.html>), Exhibit-
17 0011(http://openletters.info/ol-pdfs/0003/20200811_FD-EXH-0011-ROBERT).

18 On the possibility that you may be wondering why the name of the file is not more
19 descriptive it is because we have already run into problems with accessing those
20 files if the name is too long.

22 01.06.04. The printing of website pages will normally have the website link on the
23 bottom left hand corner of the document. As an example this document has
24 (<http://openletters.info/dpsslaca/index.html>) imprinted in the left bottom portion of
25 the document. It also has on the bottom right hand corner of the document the date
26 that it was printed. Most of the emails will have the date that it was printed and
27 shortly there after it was uploaded to our website.

3 On June 11, 2011 Robert was diagnosed with diabetes and diabetic neuropathy. As
4 a man who had been self-employed most of his life this was a severe blow. And,
5 unlike in most cases of diabetes, his nerve damage was sudden and severe.
6

7 He was a runner and distance walker and shortly before this diagnoses he was
8 forced to start using a wheel chair or crutches to get around because of pain in his
9 feet and balance issue caused by nerve damage. When the neuropathy damage did
10 not match the length of time and severity of his diabetes, there was more testing. It
11 was discovered that the neuropathy damage was to the trunk nerves in his arms and
12 calves rather than the finger tips which is traditional in diabetes when sugar
13 damages the small nerves. This also explained the severe pain he was always in
14 and why it felt like his feet were broken.

16 Not only did Robert lose his mobility but he lost his 150 word a minute typing
17 ability as well. His fingers just did not work the same anymore and the pain in
18 them and his legs was a constant 8. For those who do not know the pain scale used
19 in the medical world that is high.
20

21 While he was always a fan of voice recording now it was a necessity for note
22 taking and such. He also became skilled in the use of voice recognition software
23 and its limitations, slowness and frustrating inaccuracies.
24

25 Now everything takes impossibly longer to do if he can do it and if not he needs to
26 get assistance or do some work around. At the same time, the pain keeps his sleep
27 irregular and he struggles with fatigue which also eats away at the time he has for
28 getting stuff done.

7 03.01.02. Those about 200 documents have additional evidence that needs to be
8 dealt with. That includes each and every conversation with (LACO DPSS) staff
9 has been digitally recorded with at least my side of the conversation only. And
10 don't worry they can be used in a court of law because I kept the Digital Voice
11 Recorder so that it would be far enough to not have within that recording what the
12 party that I was speaking to had said.

14 03.01.03. All conversations with Administrative Law Judges (ALJ) were recorded
15 with both sides of the conversation with notice being given by myself that I was
16 doing just that without any objection been offered by any participants in those
17 telephonic hearings.
