What I have received is a letter stating that my medi-cal was approved.[See Attached-20171003 DPSS NOTICE OF ACTION MEDI-CAL APPROVAL.PDF]

I also received a letter before that, stating that I was being transfered to a differnt program and getting IHSS through IHSS residual, it stated my hours in this program 147:13 the same as I have been getting. [See Attached-20170831 NOA IHSS EFF 20170901 MOVED TO IHSS RESIDUAL.PDF]

I have not yet received a letter I have expected to see, saying I was moved back to the Community First Choice Program because I have medi-cal. It is a letter I have received before when my medi-cal was canceled unexplainedly and was reinstated by La France Tolivers office.

Even without that, my time sheet should not have changed as the hours did not change.

I was shocked to see the time sheet with less hours. It looked like my IHSS had been canceled. As I said I have not received any notice of that and if I had I would have appealed it.

Please find out what is going on.

The time sheet was completed as it was and sent in and we received that pay but, I would expect this to be fixed so that we get the hours for the days that had zeros, October 10th to the 15th, including the additional hours so that it is corrected. This likely requires a new time sheet.

I am also concerned that I will not get a time sheet for the next pay period, October 16th through the 31st either. As I said it looked like somehow my IHSS had just stopped.
