In preparing to send this e-mail to you and testing to make sure that everything was working from a technical standpoint I discovered that it was not. What I mean by that is that when all I was putting the file names of the Exhibits because of the way the Microsoft Windows operating system works is that it does not put the .pdf on the file name which affected the links for Exhibits 0011 to 0019. I struggled with how to fix this issue in an attempt not to change the text of what was placed in the Declaration document. In the end result the following was the best solution:

01. INTRODUCTION:

01.01. It is my strongest hope, desire, and goal to not sound or be rude, unkind, or to show any disrespect as I make my following remarks.

01.02. It is also my strongest hope, desire, and goal to communicate with you as truthfully and clearly as I possibly can so that you would understand what I am trying to say to you and thereby no misunderstandings between us develops any more than it already has.

01.03. To that end if you believe there is a misunderstanding or something does not make sense to you, please do not hesitate to contact me.

01.04. It is however my complete and total expectation that you would have read my entire set of documents, not just skimmed it, or done something like just looking at the first and last paragraph of each document.

01.05.01. I am not a lawyer. I am making statements within this legal filing that will need to be dealt with, by disinterested legal bodies.

01.05.02. The problems that have taken place with the Los Angeles County Department of Public Social Services(LACO DPSS) have gone on since within days (August 17, 2012) of us walking into their Lancaster, California office. The first time that I wrote an e-mail was on 20121214_1307 also known as (AKA) December 12, 2012 at 1:07 PM.

01.05.03. Please find for you, Judge Brian C. Yep Exhibit-0010 and for Anita Susan Brenner, the lawyer representing the Los Angeles County(LACO) a public entity and the Los Angeles County Board of Supervisors (LACO BOS). As both of you can see that it is a printing of a document which has in the top right hand section of the document CASE #19AVCP00260. At the center bottom of the document is the Exhibit-0010. If you look at the date and time of the document in the upper portion of the document you will see that the time is Eastern Time since the server that we use is in the Eastern Time Zone.

01.05.04. For Anita Susan Brenner, all of these uploaded files will be in the folder that is dedicated for this case #19AVCP00260. That folder is (<http://openletters.info/ol-pdfs/0003/>). All the file names will begin with (20200811_FD the FD stands for Filed Date, the date that it was filed with the Lancaster, California court. Obviously the EXH stands for Exhibit and the 20121214_1307 stands for the date and time of the original document at the following website link: (<http://ourlegalsystemisbroken.com/ca-gov-ol/>) which I had submitted to the court in my initial filing.

01.05.05. For other documents Exhibits I will do the same thing as I described in (01.05.03. and 01.05.03.) as long as it does not interfere with the text on the document.

01.06. Judge Brian C. Yep, while I would like very much to print each and every document of the estimated about 200 documents that I have written and that are posted on our website (<http://ourlegalsystemisbroken.com/ca-gov-ol/0003>), (my Exhibit 0002, which was filed with the initial lawsuit/petition) I have several challenges to be able to do just that. 01.06.01. First and foremost I do not have any kind of confidence that in me doing just that they you Judge Brian C. Yep, would not find that action to be to use the word that you stated when I was in your courtroom on February 6, 2020 which was "inappropriate".

01.06.02. My financial resources. What I mean by that is my rather high concern that I will run out of toner in my printer and I do not have additional toner to place in the printer when that happens.

01.06.03. My physical body resources. What I mean by that is what we have stated on our website (<http://openletters.info/dpsslaca/index.html>), Exhibit-0011(http://openletters.info/ol-pdfs/0003/20200811_FD-EXH-0011-ROBERT). On the possibility that you may be wondering why the name of the file is not more descriptive it is because we have already run into problems with accessing those files if the name is too long.

01.06.04. The printing of website pages will normally have the website link on the bottom left hand corner of the document. As an example this document has (<http://openletters.info/dpsslaca/index.html>) imprinted in the left bottom portion of the document. It also has on the bottom right hand corner of the document the date that it was printed. Most of the emails will have the date that it was printed and shortly there after it was uploaded to our website.

On June 11, 2011 Robert was diagnosed with diabetes and diabetic neuropathy. As a man who had been self-employed most of his life this was a severe blow. And, unlike in most cases of diabetes, his nerve damage was sudden and severe.

He was a runner and distance walker and shortly before this diagnoses he was forced to start using a wheel chair or crutches to get around because of pain in his feet and balance issue caused by nerve damage. When the neuropathy damage did not match the length of time and severity of his diabetes, there was more testing. It was discovered that the neuropathy damage was to the trunk nerves in his arms and calves rather than the finger tips which is traditional in diabetes when sugar damages the small nerves. This also explained the severe pain he was always in and why it felt like his feet were broken.

Not only did Robert lose his mobility but he lost his 150 word a minute typing ability as well. His fingers just did not work the same anymore and the pain in them and his legs was a constant 8. For those who do not know the pain scale used in the medical world that is high.

While he was always a fan of voice recording now it was a necessity for note taking and such. He also became skilled in the use of voice recognition software and its limitations, slowness and frustrating inaccuracies.

Now everything takes impossibly longer to do if he can do it and if not he needs to get assistance or do some work around. At the same time, the pain keeps his sleep irregular and he struggles with fatigue which also eats away at the time he has for getting stuff done.

Anita Susan Brenner has made the following statement:

02. "V. Petitioner Cannot Establish a Probability of Prevailing on His Claim, So This Action Must Be Dismissed 7"

02.01. Anita Susan Brenner is not God, Anita Susan Brenner is not omniscient, Anita Susan Brenner does not know all things now and in the future.

02.02.01. I do not know how Anita Susan Brenner can make a statement like that went somewhere in the neighborhood of about 200 documents establishing a pattern of one or all of the following:

02.02.02. Incompetence, just not caring one iota for their "customers", malfeasance, retaliation, lying, and perjury on documents and in sworn testimony before Administrative Law Judges (ALJ).

Anita Susan Brenner has made the following statement:

03. "A. The petitioner cannot meet his burden of showing a legitimate basis for this lawsuit 7"

03.01.01. I do not know how Anita Susan Brenner can make a statement like that when somewhere in the neighborhood of about 200 documents are posted. Those about 200 documents actually have content and text within them. They are not just sitting there without any content that is dealing with by and large real issues and problems with (LACO DPSS).

03.01.02. Those about 200 documents have additional evidence that needs to be dealt with. That includes each and every conversation with (LACO DPSS) staff has been digitally recorded with at least my side of the conversation only. And don't worry they can be used in a court of law because I kept the Digital Voice Recorder so that it would be far enough to not have within that recording what the party that I was speaking to had said.

03.01.03. All conversations with Administrative Law Judges (ALJ) were recorded with both sides of the conversation with notice being given by myself that I was doing just that without any objection being offered by any participants in those telephonic hearings.

03.01.04. There has also been attempts by (LACO DPSS) of what appears to be entrapment on my part so that they can charge me with a felony.

03.01.05. I have heard from Confidential Informants(CI'S) that the experiences that I have needed to deal with (LACO DPSS) staff.

03.01.06. I am providing the following into evidence. This is a small fraction of the documents that can prove what I am speaking of:
