02.03. La France Toliver, As you are well aware since you have had to fix many of these problems I am attempting to do everything that I can do to not have there be any more problems than there have been in our almost ten (10) year business relationship[101]. I am having to spend hours and hours attempting to communicate as diplomatically as I can that the last time I had to do documents Michael Guerra refused to accept an Electronic Signature.

02.04. La France Toliver, please, please, please let whoever of the (LACO DPSS) employees who will retaliate[05] against me that I and (LACO DPSS) documents communicate that (LACO DPSS) employees need to do everything that they can do to minimize and attempt to solve whatever problems at the lowest possible levels so that those issues do not have to go before an Administrative Law Judge (ALJ) to argue the agreement that you La France Toliver and your boss at the time Derrick Robinson and I agreed to in or about April of 2013 (yes, nine years ago).
