

1 Motion to reject Anita Susan Brenner "motion to strike".

2
3 Motion to reject Anita Susan Brenner "motion for attorney fees".

4
5 Introductory Recitals:

6
7 It is my strongest hope, desire, and goal to not sound or be rude, unkind, or to show
8 any disrespect as I make my following remarks.

9
10 It is also my strongest hope, desire, and goal to communicate with you as truthfully
11 and clearly as I possibly can so that you would understand what I am trying to say
12 to you.

13
14 Since I happen to know from one or more of the self help law books that I read that
15 I am to limit my remarks to about 15 minutes I will attempt to do just that. I have
16 prepared remarks so that I can take the least amount of time.

17
18 My awesome wife Gail is here in the courtroom and has pushed my wheelchair
19 into position to be able to speak to you this morning.

20
21 Since I also happen to know that on December 17, 2019 when I had a phone
22 conversation with Anita Susan Brenner I was interrupted on more than one
23 occasion I would kindly ask your honor to keep Anita Susan Brenner from
24 interrupting me.

25
26 I was truly shocked and very, very, very, disturbed by my conversation with Anita
27 Susan Brenner on numerous fronts.

1 Because I was born in Baghdad, Iraq, and I legally immigrated to the United States
2 in 1969 as a 12 year old boy with family members. I became a U.S. citizen in
3 1976, the two 200th anniversary of America's Independence.

4
5 The English language was my fourth language I use communication tactics,
6 policies and procedures because I am extremely concerned that people might
7 misunderstand what I am attempting to communicate to them. That
8 communication includes but is not limited to communicating by using examples
9 and picturesque language again so that people do not misunderstand what I am
10 attempting to communicate to them.

11
12 I also bring up where I was born because it greatly affects what this case is all
13 about. My awesome wife Gail is allergic to practically every animal hair on the
14 planet. In that same way I am allergic to bad government anywhere in the USA.
15 In the year 2014 I attended a citizenship ceremony at the LA convention center.
16 Part of that ceremony were remarks by a Federal Judge. With the over 4000
17 individuals being sworn in to become USA citizens including our friend who
18 invited us. That Federal Judge delivered remarks that were incredibly inspiring.
19 Those remarks were inspiring for many reasons that included but was not limited
20 to encouraging those brand new USA citizens to get involved in all aspects of their
21 new government. I was struck by what I thought I heard back in 1976 when I
22 became a U.S. citizen. My awesome wife Gail and I have suffered greatly to do
23 what seemingly both Federal Judges communicated that we as new USA citizens
24 even though those two judges were 38 years apart in their remarks to yours truly in
25 1976 and my attendance in the year 2014.

26
27 None of those words ever cross the line of using foul language. For me it is not
28 about people agreeing with my communication but it is that they understand what I

1 am attempting to communicate to them. That is why I admire and love that we as a
2 nation have the First Amendment.

3
4 Since Anita Susan Brenner, esq. references my two phone calls with Anita Susan
5 Brenner, esq. and what happened during both the phone calls, Anita Susan
6 Brenner, esq. was extremely offended at what I thought to be kind, thoughtful,
7 caring, and gracious statements I will refer to Anita Susan Brenner, esq. by the
8 name Anita Susan Brenner rather than using such words as gender words so as to
9 not potentially be accused of inappropriate communication and then being told that
10 I as a pro per should know everything that an attorney would know and obviously
11 why what I said was so offensive.

12
13 So, as not to potentially offend Anita Susan Brenner, esq. I will refer again to as
14 Anita Susan Brenner rather than Anita Susan Brenner, esq. since it is extremely
15 problematic in the writing of this document since the "voice recognition software"
16 that I am using cannot distinguish between Anita Susan Brenner, esq. versus a
17 period from this point forward.

18
19 On page 13 in the section of:

20
21 Declaration of Anita Susan Brenner In support of defendant county's special
22 motion to strike

23
24 Number six on that page what Anita Susan Brenner does not state that I said to
25 Anita Susan Brenner:

26
27 "Mr. Colaco admitted that the decision that is the subject of his petition was in his
28 favor. His position (not his exact words) was that county employees had lied and

1 this merited further litigation even though the decision was in his favor. We were
2 unable to resolve the issues presented in the present motion."

3
4 Anita Susan Brenner did not include that I stated what is a decision when it is in
5 fact meaningless trash not even recyclable trash. I also stated to Anita Susan
6 Brenner that when I believed that LACO DPSS employees were acting in an illegal
7 manner I wanted nothing to do with that.

8
9 Anita Susan Brenner demonstrated by not asking any further questions that Anita
10 Susan Brenner could not care one iota about the issues that I raised immediately
11 above.

12
13 Anita Susan Brenner went on to tell me that I should consider my decision and that
14 I should call Anita Susan Brenner the following morning or Anita Susan Brenner
15 would file "ANTI-SLAPP MOTION". I went on to tell Anita Susan Brenner that
16 since I happened to know what that is and I went on to a basically tell Anita Susan
17 Brenner what I believed that was which has been clearly demonstrated by Anita
18 Susan Brenner legal filings.

19
20 I want to compliment Anita Susan Brenner for one thing. Anita Susan Brenner
21 postmarked those legal filings on December 19, 2019. Since we spoke on
22 December 17, 2019 and ended my notes of the conversation at 16:01 hours (4:01
23 PM) Anita Susan Brenner followed through on the commitment that Anita Susan
24 Brenner made.

25
26 Anita Susan Brenner states IN:

27
28 "Memorandum of points and authorities in support of special motion to strike.

1
2 I. Plaintiff seeks review of a decision in his favor"

3
4 Anita Susan Brenner Relied heavily on selected. I would strongly encourage this
5 court to read my Exhibit 0001 so as to determine the proper context. This is a
6 document that was intended and is intended to end up as we stated at the top of the
7 document:

8
9 "We at Citizens For A Better America(R) (CFABA.ORG) are sending this News
10 Release to email addresses on public websites primarily beginning with searches at
11 (ilrg.com/nlj250). If you believe you have received this News Release by mistake,
12 my apologies."

13
14 When any one with Internet access copies and pastes (ilrg.com/nlj250) into their
15 Internet browser they will discover that website page is the first website page of
16 seven website pages that have the 350 largest law firms in the United States of
17 America.

18
19 We have searched those websites to discover any and all e-mail addresses that are
20 on those websites. Many of those websites have their lawyers by name, phone
21 number, and most importantly to us their e-mail address. By the way before Anita
22 Susan Brenner does a whistleblower complaint against yours truly for the
23 perception that I have committed illegal activity, we searched those public
24 websites WITHOUT violating any of those websites in anyway shape or form.

25
26 Q. Why in the world did I spend the time and energy for a gentleman that has very
27 limited amounts of both to deal with everything that I have dealt with from "Anita
28 Susan Brenner states IN:"?

A. By all the actions of Anita Susan Brenner since we spoke of December 17, 2019 to today, Tuesday, January 21st 2020 here we all are in your court room your honor. That document clearly spells out what is being done with that document. By all of the evidence that is available to me Anita Susan Brenner is attempting to absolutely destroy me before I am able to do what I have said in my legal filings:

"It was my intent, it is my intent, it will be my intent to convert this lawsuit to a minimum of 1 Billion Dollar Class Action Lawsuits(TM)."

In all of the nightmarish time that we had to deal with Judge Kathleen Blanchard I had a problem with practically everything she said and did. The one thing that I did not have a problem with was when Judge Kathleen Blanchard was attempting to encourage a gentleman that was in lockup (He had the customary clothing) to get legal counsel (with great effort on the part of Judge Kathleen Blanchard).

In a potential demonstration of how even though myself and family members have been in the USA since Labor Day weekend 1969 I will make an effort to not mess this up:

"If it walks like SADDAM HUSSEIN's legal system, if it quacks like SADDAM HUSSEIN's legal system, then it is SADDAM HUSSEIN's legal system."

4
5 As it pertains to this specific lawsuit petition against LACO DPSS I want to do all
6 I can do to stop LACO DPSS from doing the kinds of abusive behavior that they
7 have done to us, which includes but is not limited to:

8
9 01. By all the evidence that is available to me massively retaliating against us for
10 holding them accountable and revealing their misdeeds.

11
12 02. By all the evidence that is available to me committing perjury in sworn
13 testimony.

14
15 03. By violating an Administrative Law Judge (ALJ) order that was absolutely,
16 positively and unequivocally clear in what they were to do. They did not do what
17 that (ALJ) order was and then would go on to lie about it for over a year.

18
19 04. By all the evidence that is available to me that the "Los Angeles County Board
20 of Supervisors" (<https://bos.lacounty.gov/>), with what I believe to be the same
21 five supervisors in district number order Hilda L. Solis, Mark Ridley-Thomas,
22 Sheila Kuehl, Janice Hahn, Kathryn Barger had the opportunity to discover these
23 issues in the month of May of 2018 when we published all of the emails that we
24 had ever sent to either LACO DPSS or CA DSS (my exhibit 0002) and they chose
25 to not do anything about it and to not fix the problems.

26
27 If I were to use the same communication Anita Susan Brenner used actually
28 questioning my integrity and communicating that our filing for this lawsuit petition

1 is not timely because it was not done on the date that it was mailed by CA DSS
2 that very exhibit was not properly done even though my version was NOT messed
3 up so as to bring potential problems when viewed by your honor. Those
4 supervisors that had anything to do with not fixing these problems and having a
5 contract with Anita Susan Brenner who is not only attempting to absolutely destroy
6 the life of someone who has qualified to be on General Relief (GR) also known as
7 welfare since December of 2018. I am speaking of yours truly.

8
9 05. By all the evidence that is available to me those same "Los Angeles County
10 Board of Supervisors" having a contract with Anita Susan Brenner to destroy the
11 people's lives that have had dealings with child issues since Anita Susan Brenner
12 erroneously had that in the legal filings.

13
14 06. By all the evidence that is available to me those same "Los Angeles County
15 Board of Supervisors" operating (LACO DPSS) as if they were operating the
16 pentagon or the CIA not the Los Angeles County Department of Public Social
17 Services (LACO DPSS) as I have stated to the two individuals that I have been
18 speaking with at (LACO DPSS) La France Toliver and Michael Guerra the two
19 high ranking officials at (LACO DPSS) headquarters.

20
21 07. By all the evidence that is available to me those same "Los Angeles County
22 Board of Supervisors" should hang their heads in shame based on what I said in
23 (04.). directly above.

24
25 Anita Susan Brenner acting in really BAD FAITH:

26
27 Anita Susan Brenner has demonstrated to me in an excellent manner that our legal
28 system is broken (ourlegalsystemisbroken.com) because it would appear that Anita

1 Susan Brenner is able to get away with this highly inappropriate behavior that
2 Anita Susan Brenner has done.

3
4 01. By all the evidence that is available to me Anita Susan Brenner went over my
5 "pleading papers" and my exhibits since Anita Susan Brenner states the following:

6
7 "Counsel for responding party estimates that defense costs will be at least 30 hours.
8 Defense counsel's reduced hourly rate to the County of Los Angeles for this case is
9 \$180.00. Defendant request and order directing plaintiff to pay to Defendant
10 County of Los Angeles the minimum amount of \$5,400.00, as set forth in the
11 declaration of Anita Susan Brenner...

12
13 02. Because I State the following in that same open letter document:

14
15 "Three. USPS snail mail. We normally go to pick up our mail at our PO BOX
16 1949, LITTLEROCK, CA 93543-5949 once every 2 to 6 weeks. We have had
17 lawyers who actually care about us send an e-mail and then take that same
18 document and send it by USPS snail mail."

19
20 So, Anita Susan Brenner would have a very serious opportunity to believe that we
21 would not have been able to receive these documents so that we could do
22 something about them. Since I have already experienced in problems that I have
23 had with attorneys and knowing that bar associations fail in protecting non
24 lawyers.

25
26 03. Sending me a packet that is what Anita Susan Brenner stated was my 53 pages
27 plus what ever Anita Susan Brenner added to it. What could have taken yours
28 truly less than 10 minutes because I would have been able to scan Anita Susan

1 Brenner documents and have had my computer reading Anita Susan Brenner
2 documents back to me as well as to be able to copy and paste every time I quoted
3 Anita Susan Brenner.

4
5 As far as I am concerned when Anita Susan Brenner was well aware of my 147.13
6 hours of In Home Supportive Services (IHSS) this is a severe trashing of my
7 "Americans With Disabilities Act" (ADA) protections and rights.

8
9 Prayer For Relief:

10
11 01. While I have personally forgiven Anita Susan Brenner for attempting to
12 intimidate, and bulley yours truly from pursuing a very legitimate case of
13 malfeasance on the part of (LACO DPSS). I kindly ask that your honor sanction
14 Anita Susan Brenner the \$5,400.00 for the court to get those funds to then have
15 those funds to go to a nonprofit organization helping the 3 1/2 million Los Angeles
16 County residents having to do business with (LACO DPSS).

17
18 02. In another case presided over by Judge Randolph A. Rogers in this very
19 Courthouse in Lancaster, California after reading:

20

25 On page 20 of 21 in exhibit 0001 decided that there was no way that I would want
26 to take away any ones first amendment right of free speech even though the
27 opposing counsel argued vociferously to get him to change his mind.

1 03. I did what I did with Anita Susan Brenner over the issue of recording because
2 I wanted Anita Susan Brenner to know that was something that I did ON each
3 phone call whether they were both sides of the conversation as was the case with
4 my phone hearings with the Administrative Law Judge's (ALJ) or my side of the
5 conversation only with everyone that I have spoken with at (LACO DPSS). I have
6 all of those recordings.

7
8 Obviously all those recordings need to be transcribed that is why I am doing
9 everything that I can do to find lawyers and law firms to bring those minimum one
10 billion dollar class action lawsuits (bottom line so that they would be motivated to
11 take these cases). Again, please read that entire document.

12
13 04. I patiently waited for (LACO DPSS) to do "Good Behavior" rather than "Bad"
14 for one whole year. I ask your honor to give me one year to find those lawyers and
15 law firms so that I am not an absolutely abused by cut throat attorneys contracted
16 by the "Los Angeles County Board of Supervisors" like Anita Susan Brenner.

17
18 05. To reject Anita Susan Brenner "motion to strike".

19
20 06. To reject Anita Susan Brenner "motion for attorney fees".

21
22 07. There is more that I would like to say but I'm just out of time.

23
24 08. Would this court kindly stamp this document and send it to Anita Susan
25 Brenner since we do not have the resources to do that. Since we have survived
26 these 14 months by the kindness of our Church family including today.

1 09. For Anita Susan Brenner to never again send me a packet like this one which I
2 would potentially destroy in getting to the papers.

3
4 10. I am fairly certain that Anita Susan Brenner will argue that there is no way
5 Anita Susan Brenner can wait that long or for this court to wait that long. Bottom
6 line WE ARE THE ONES WHO ARE SUFFERING. My awesome wife Gail has
7 not been paid since April 16, 2018.
