02.01. Again, I cannot emphasize this point enough that we normally do not send emails with attachments in them, so we do not know whether our Email System will allow for that to occur and we will not know until we have actually attempted to do so and completed that task. However, we will also post those same files on our (openletters.info) at the same place that we are posting this "Open Letter(OL)".

03.06. The actual .DCF "FECFILE" files that we are attempting to send with this email and also posting are as follows:
