In our last filing with your office I sent you an Open Letter(OL) whose text is within this Open Letter(OL) in between the characters of === and the characters of ===. I do not have a record of receiving a response from you and or your office.

Because of all the problems that our political organization has had with your government entity I have no choice but to continue to send for a lack of a better term "Reminder Letters" in an effort to get a response from you. I continue to await your response.

However, I do have a very serious problem with your government entity's communication with me about that issue. I have been absolutely, completely, and overwhelmingly frank, honest, and fully transparent with your government entity.

04. I do not know whether your government entity have actually taken the time to actually FINISHED READING MY Open Letter(s) in their entirety. 03. Check number 10723 in the amount of \$50.00 for the year 2021 fees.

2020 fees:

I was unable to pay for the year 2020 fees because of a lack of funds to do so. Since as I have understood that the \$150 penalty for nonpayment of the non paid year 2020 fees is if those fees are late by one day or years it is the same \$150 penalty.

We are on public assistance and we have had enormous problems with the Los Angeles County Department of Public Social Services (LACO DPSS). Those problems all are a matter of public record you can see all of the letters that we have sent to them by clicking on the following link:

If you go to that link you will see that there are six pages of titles only of letters we have written to them. Each one of those titles has a letter attached to it as a PDF.

The last letter is a recap of what has taken place with them when we were asking for consideration because at the time we did not have toner in our printer to be able to print a document that they needed. They did not tell us that basically at the time that that we had sent that letter to them that we were already removed from our \$375 monthly payment being received by us. So, bottom line the \$375 monthly payment that we would begin to receive after we sent the 2020 reports to your government entity we again as of December 2020 are no longer receiving.
